All programs and facilities of the Peterborough Recreation Department are open to all citizens regardless of age, sex, sexual orientation, race, creed, color, marital status, familial status, physical or mental disability or national origin.

Rules & Regulations for use of the Town of Peterborough's Parks:

These rules are based on Town Ordinances and the policies of the Recreation Committee. Failure to comply can result in a fine by the Peterborough Police Department.

- 1. Vehicle travel and parking is restricted to paved roadway or parking lot areas. Use of other park surfaces for vehicles is strictly prohibited.
- 2. Carry out what you carry in.
- 3. Respect the park's neighbors and their property.
- 4. No pets allowed on athletic fields.
- 5. No pets allowed without a leash. Pet waste must be picked up and carried home with you, not disposed of in park trash receptacles.
- 6. No alcohol, cigarette/cigar smoking, chewing tobacco or illegal substances permitted.
- 7. No firearms permitted.
- 8. No fires or fireworks permitted.
- 9. No commercial business unless approved by Recreation Committee and/or other Town authority.
- 10. Always leave the park as good or better than you found it.
